## TOYOTA COMMUNITY TRUST STEM TEACHERS SCHOLARSHIP 2024 INFORMATION KIT

The Public Education Foundation's Toyota Community Trust STEM Teachers Scholarship supports public school teachers across Australia involved in all aspects of STEM teaching.

Nine scholarships are available nationally, each of which will provide \$10,000 per scholar to cover the cost of pursuing professional development courses in STEM-related subjects.

Applications from teachers working in rural, remote or low socio-economic schools across Australia are strongly encouraged.

### BASIC ELIGIBILITY

- Currently teaching STEM subjects in a public school in Australia;
- A minimum of two years' experience in STEM related subjects;
- Committed to continue as a teacher involved in STEM teaching in the government school system for at least another 5 years;
- Be available to share your learnings and act as an Ambassador for the Public Education Foundation and Toyota Community Trust (if applicable) after the professional development experience;
- Be an Australian citizen or permanent resident.

## SELECTION CRITERIA

- Evidence of significant commitment as a STEM teacher;
- Commitment to the values of public education;
- Evidence of a candidate's enthusiasm for furthering their own professional development and education;
- A clearly articulated demonstration of the need for the requested professional development, and their expected outcome from those;
- How the knowledge will be implemented in the classroom and shared with colleagues in their school;
- Other STEM experience and/or personal qualities and/or personal circumstances that would enhance the candidates suitability for a Toyota Community Trust STEM Teachers Scholarship.

## SELECTION PROCESS

A selection panel will review all scholarship applications and assess them against the selection criteria. The selection panel will include representatives of the Public Education Foundation, Toyota Community Trust and independent experts. After considering all applications, the selection panel will recommend the selected applicants for the approval of the Public Education Foundation's Board. The selection panel reserves the right to ask shortlisted applicants to participate in an interview.

## APPLICATION FORM AND ATTACHMENTS

To apply for the Toyota Community Trust STEM Teachers Scholarship, applicants can access the link to the online portal via the Foundation's website -

Please note that all applications are now received via the Foundation's online portal.

Prior to starting your application, you should compile the following information ready to submit:

- Applicant details including:
  - full name
  - phone number
  - address
  - email
- Residence status
- Month and year you commenced teaching

- School details:
  - name of school
  - address
  - principal name
  - email
  - total enrolment
  - student attendance rate
  - % of Indigenous students
  - % of EALD students
  - % of students with special needs
- Please also outline your plan for professional development including:
  - Short description of requested course/s (**must be AFTER February 2024**) including anticipated costs (including any travel costs associated with the study – maximum 300 words – completed online). **Scholarship funds CANNOT be used for “back-filling” your position while you undertake any of your proposed PD.**
  - Your plan for professional development and expected outcomes for yourself (maximum 300 words – completed online)
  - Your plan for sharing your knowledge with colleagues and implementing your knowledge in the classroom (Maximum 200 words – completed online)
- A personal statement about yourself, your commitment to teaching and public education and how the course/s (and scholarship) will contribute to the plans and goals for yourself and your school (Maximum 400 words – completed online)
- A reference from your Principal confirming their commitment to supporting your study and releasing you from teaching if necessary to undertake the study (PDF or Word format, maximum 400 words). **This reference should ideally be provided on letterhead. AT A MINIMUM references must include the referees name, title and be signed and dated**

**Note for Principals: Please be aware that your reference is a critical component of the application form and your feedback is given considerable weight in the process of panel deliberations. The panels are looking for feedback that goes well beyond simple confirmation that the teacher is employed at your school, and should include what you believe the applicants potential is as a teacher and future leader.**

## SUBMITTING YOUR APPLICATION

Once you have finalised your application and all elements are complete (including references as required) you can submit it for review.

**Applications must be submitted by 11.59pm on Tuesday 31st October 2023.**

Please note that if you are selected as the successful recipient of this scholarship you will be required to submit a detailed proposal of your intended study, with associated expenditure, for approval prior to the funds being made available to you. ***Funding will be made available from February 2024 so your requested course/s must take place after this date.***

**Please also note that any professional development must be completed within eighteen months of being awarded the scholarship (by mid-2025). {This may be reviewed in extenuating circumstances}.**

On completion of your course (or each course, should you be undertaking more than one course as part of your scholarship), you are also required to provide an update to the Public Education Foundation and Toyota Community Trust telling us about your course/s and explaining how you feel you have benefited from your professional development and the scholarship.
